On August 18, 2023, PTTEP Australasia (Ashmore Cartier) Pty Ltd (PTTEP AAA), a subsidiary of PTTEP, entered into a Sale and Purchase Agreement (SPA) to sell its total interests in petroleum retention lease, Cash Maple (AC/RL7), to INPEX Cash Maple Pty Ltd. and TotalEnergies Exploration Australia Pty Ltd. PTTEP AAA holds 100 percent interests in the retention lease and the divestment was completed on December 22, 2023.
